## SPECIAL USE PERMIT FEE SCHEDULE EFFECTIVE 1/1/06

**Required Operational Permits.** The Fire Marshal is authorized to issue operational permits for the uses and operations set forth in this schedule.

TYPE OF PERMIT	FEE	DESCRIPTION
<b>CARNIVALS AND FAIRS</b>	\$100 Per Day (Maximum Length of Permit: 7days) Plus the Cost of Required Standby Personnel)	This inspection fee is required to obtain an operations permit to operate a carnival, fair or similar event.
<b>COMPRESSED GASES</b>	\$25 Per ICC Hazard Classification	This inspection is required to obtain an operations permit to store, use or handle at normal temperatures and pressures compressed gases in excess of these amounts: Corrosives: 200 cu. ft; Highly Toxics: any amount; Inert and simple asphyxiants: 6000 cu. ft; Irritant: 200 cu. ft; Other Health Hazards: 650 cu. ft; Oxidizing: 504 cu. ft; Toxic: any amount; Pyrophoric: any amount; Radioactive: any amount; Sensitizer: 200 cu. ft; Unstable: any amount.
<b>EXHIBITS AND TRADE SHOWS</b>	\$25	This inspection fee is required to obtain an operations permit to operate exhibits and trade shows.
<b>OUTDOOR PUBLIC FIREWORKS DISPLAYS</b>	\$600 Per Day Plus the Cost of Required Standby Firefighting Personnel & Apparatus	This inspection fee is required to obtain an operations permit to conduct an outdoor fireworks display. This fee can be waived at the discretion of the Fire Chief.
<b>HIGH-RISE BUILDING</b>	\$100 Per Floor	This inspection is required to obtain an operations permit to operate a building classified as a high-rise building as defined by the building code.
<b>HOTEL</b>	\$25	This inspection fee is required to obtain an operations permit to operate a hotel as defined by the building code.
<b>LIQUIFIED PETROLEUM GASES</b>	\$100	This inspection fee is required to obtain an operations permit to store, use handle or dispense LP-gas, Liquid or gas-fueled vehicles or equipment in assembly buildings.
<b>PYROTECHNICAL SPECIAL EFFECTS MATERIAL</b>	\$150 Review Fee Plus Cost of Required Standby Personnel (A Portion of this Fee may be Waived if Multiple Events are Within the Same Day)	For permits for pyrotechnical special effects material.
<b>RADIOACTIVE MATERIAL</b>	\$100	This inspection fee is required to obtain an operations permit to store or handle at any installation more than 1 micro curie of radioactive material not contained in a sealed source or more than 1 mill curie of radioactive material in a sealed source or sources, or any amount of radioactive material for which a specific license from the Nuclear Regulatory Commission is required.

TYPE OF PERMIT	FEE	DESCRIPTION
SPECIAL EVENT	\$100 Per Day. (Maximum length of permit: 7 days) Plus Cost of Required Standby Personnel	This inspection fee is required to obtain an operations permit to operate a special event not classified as a carnival or fair that is open to the public.
TEMPORARY MEMBRANE STRUCTURES	\$25	This inspection fee is required to obtain an operations permit to operate an air supported temporary membrane. This fee can be waived at the discretion of the Fire Marshal or Fire Chief.
TENTS OR CANOPIES	\$75 (Maximum Length of Permit: 30 days)	This inspection fee is required to obtain a permit to erect or operate a tent having an area in excess of 200 square feet, or a canopy in excess of 400 square feet, except for structures used exclusively for camping. In addition, special event fees may apply if tents are used as part of a special event. This fee can be waived at the discretion of the Fire Marshal or Fire Chief.

**NOTES:**

1. This fee schedule is approved by the Board of Directors per CRS 32-1-1002(1)(e)(II).
2. The Fire Marshal or Fire Chief is authorized to make interpretations and clarification changes to the fee descriptions.
3. The Fire Marshal or Fire Chief is authorized to collect inspection fees or construction permits and for other items set forth in this schedule.
4. The Fire Marshal or Fire Chief may waive or reduce fees for non-profit organizations or other governmental agencies. The business or facility must apply in writing to the Fire Marshal or Fire Chief to waive such fees.
5. Confidence-testing fees apply to all facilities that have fire or life safety systems that are required to be inspected on a regular basis, by the fire code or other nationally recognized standard.
